



**Odyssey of the Mind-Texas Officials Housing

Dear Texas Odyssey Official,

Thank you for supporting Texas State Odyssey of the Mind and our children with your valuable time and efforts. Odyssey of the Mind-Texas will pay the hotel bill for your stay during our 2011 State Odyssey of the Mind tournament based on a **two-person** occupancy. The room rate for **one** of the judges in a two person room will be \$26.55 per person plus half of the applicable non-tax exempt tax (\$4.52). The full room rate is \$53.10 plus 17% tax. You will be responsible for any additional charges, such as long distance, movies etc.

To stay in a Judges room you must meet the following criteria:

1. You must be working at the State Tournament as a Judge or Staff.
2. You must live outside of the Houston Metroplex area.
3. It is recommended that you stay at the judges' hotel. We have negotiated special rates.
4. You will be asked to share a room when possible. Judges rooming with non-judges (not helping with State tourney) or staying alone will be asked to pay the 2nd half personally.
5. You are asked not to let teams share your room. This is a quiet area.
6. One of the two roommates must call the hotel and hold a room **with their credit card**.

RESERVE THE ROOM UNDER **“Odyssey of the Mind Judges”**.

Your credit card should not be charged unless you have additional charges to the room such as movies, etc., or you are a no show without notifying Texas Odyssey. If it is charged please contact Iris Story.

7. **You must reserve your room by April 1, 2011. That is very soon so just do it now!**
If this is not possible then Texas State Odyssey will still reimburse you for the amount that the room would have cost (\$26.55 plus \$4.51 tax). You will need to submit a check request and attach proof of payment by May 31, 2011 to be reimbursed.
8. Each roommate must fill out information on themselves and email it to me, Iris Story (Form attached).
