VI. Region Showcases

Jeff will also be running a Technical Training for all PC's. Steve will set this up with Jeff. Lilian asked to be added to this PC training as well.

There was a question about training for Prob 6 the was not able to be clarified at this meeting.

Tournament jobs will be: Head Judge – (could also serve as a problem judge); Long Term; Style: Tech Lead (Amanda?); PRO (Lilian volunteered to do this for all problems; Spontaneous;

One person on each judging team can also serve as the tech person for their problem. Head Judge will also serve as SPC.

VIII. State Tournament Planning

Each PC should submit who they would like on their judging team – (I did not record if there was a deadline for this submission)

Balsa structures will be shipped by the teams to CCI. CCI will weigh, "crush", and record the information in the scoring program.

If the PRO finds that a team's video is **obviously** edited, the PRO will contact the team to have them correct this and resubmit another video that meets the requirements. Judging of an obviously edited video will **not** take place.

Submission of videos has been moved to March 20th. Lois will get up with Walter to obtain a date for structures to be sent/received at CCI.

Scholarships will still be awarded this year. The amount budgeted was \$2,500 for the year 2021. The deadline is to be determined. The Scholarship Committee will be: Mason Story, Vera Hammond, and Sam (pending).
