III. 2022 TOURNAMENTS

• Team qualifications:

Haro proposes Primary teams don't need a judge, but 2, 2-hour volunteers, and judges are not all required to judge State.

- Regional Tournaments, on-site tentatively
 - Central March 26th Alamo Heights School District
 - North: Tentatively February 26th at Carroll High School (Waiting confirmation)
 - HARO: March 5th Waiting for confirmation from West Brier MS
- TX State tournament, on-site tentatively Harris County Council for the Arts or a school on Spring Branch ISD. Still waiting on confirmation.
- Lilian spoke about local restrictions, social distancing, and the impact on old tournament format.
 We need to consider the safety of our teams, judges and families.
 Proposed:
 - *No hangouts. Team will do long term then Spontaneous then done Majority of members say to wait until Feb to decide if this is needed.
 - *No food or drink will be sold by vendors State candidate does not allow food or drink.





*Only 2 family per team member in audience or no audience at all – Consensus was that there is no reason to make this decision now.

*Judges offering distance options - Not discussed

*Go or No-Go decision to plan on region or 1 state tournament will need to be made in the future.

*Should we consider capping the problem so as to not have multiple venues. Discussion was made about limiting the number of teams. North and Central were both apposed to this. HARO is concerned about volume of teams. It was suggested RD's stay in touch with their coordinators and keep an early running total of which problems teams are doing. Gaby will stay in contact with HARO teams.

- State-level Virtual tournament option for single team virtual memberships, organized by CCI. Will be partitioned by Association and judged individually. P2, 3 and Primary only.
- World Finals will be the weekend before Memorial Day. Tentatively in Iowa.
- Discussion was made that if we cannot do onsite tournaments, do we do a unified state tournament? This was tabled due to the unknown future but will be discussed at a later date.

IV. TOURNAMENT JUDGING

- We will maintain the centralized penalties tracking.
- PC meeting with ADs in the Fall to discuss ideas for representation and judging. Online training could be used, discussions still ongoing. Steve will put out an email with dates for the PC's and go from there. Discussion will need to be had about social distancing and judges.

V. STANDING RULES COMMITTEE, CHAIR: TERI REIST

Committee members: Teri Reist, Sandy Sook, Ann Dachniwsky Amanda Coots. Bylaws last updated in 2013. Standing Rules have no date, possibly 2016.

The committee worked to update standing rules and create board positions. They looked at other state's by-laws.

Sandy led a brief discussion and requested of us look at the standing rules and give opinions. This can be done on the Standing Rules Committee Channel on Discord. The standing rules will be looked at yearly as a working document.

Final version will be proposed in January for a vote.

VIII. PROGRAM PROMOTION


- Virtual TAGT- This year we won't benefit from going to TAGT due to it being mostly virtual. It was excluded from our budget for the year.
